

**David Xavier** (b. Nazaré, 1971) is currently the Secretary General of the Presidency of the Council of Ministers in Portugal. At SG-PCM he coordinates a team of over 240 people and is the national coordinator for the working group for the Reform of Public Administration. He is also the Portuguese representative in the network of senior officials from centers of government at the OECD.

David graduated in Business Organization and Management (ISCTE, 1996), completed the European Business Certificate in Madrid and has a master's degree in African Studies, with a field study on ICT in Mozambique (2001).

David started his professional career in the university, having hold various executive positions, from Secretary General of the Faculty of Medicine up to Administrator and Executive Director of the Shared Services, and Administrator of the Social Services of the University of Lisbon.

He is a seating member of several councils, such as the Strategic Council of the National Institute of Administration, the School Council of the Higher Institute of Social and Political Sciences, the ISCTE Quality Council, the National Civil Protection Commission, and he is an auditor for the Ministry of Foreign Affairs. At SG-PCM, David oversees the collection of the national response indicators for the Sustainable Development Goals.

David as an extensive training experience on a wide range of subjects, from public policies to the use of ERPs, leadership and public administration, namely in an international setting, as shown by collaborations with the General Secretariat of the Timorese Parliament and the Ministry of the City of Maputo.

He has authored a number of collective publications and was awarded a prize for best practice in public administration (2011) for a project within the Shared Services of the University of Lisbon.

Since ever, David has been involved in social causes and has held positions in many organizations, from the leadership of student associations, parents' associations, local sports groups, organizations working with the homeless. He has been a member of international organizations with strong links to the European Youth Centre, both in Strasbourg and Budapest, by which means he had the opportunity to get to know almost all of Europe (from Lisbon to the Urals).

He is married, has three children (all grown up now) and swims open waters, also in Nazaré, where the waves are big. David loves trains and has already taken the Sud-Express, the Orient-Express and the Trans-Siberian, climbed Machu Picchu and travelled to more than 40 countries.
